# REGULAR MEETING January 14, 2020 CHEROKEE NATION ELECTION COMMISSION

#### Call to order/Roll call of Commissioners:

The meeting of the Cherokee Nation Election Commission was called to order by Chairperson Shawna Calico at 4:06 p.m.

Commissioner Carolyn Allen called roll and a quorum was established with the following commissioners present:

#### **Approval of Minutes:**


#### 1 OFFICE:

The City of Tahlequah takes pride in the health, safety, welfare and appearance of our community and we are asking for your assistance in this effort. The placement of your campaign signs will contribute to the overall positive appearance of the neighborhoods and our community. We understand that you may not be aware of the city codes (ordinances) that pertain to campaign signs. Below is a list of the rules pertaining to the placement of campaign signs.

- 1. Residential neighborhoods: Signs shall not exceed 16 square feet and shall be placed a minimum of 15 feet from the back of the curb or street edge. Signs shall be located behind all sidewalks.
- 2. Non-Residential neighborhoods: Sign size is not restricted; however their placement is. Signs are not allowed to be placed in the street right-of-ways. Due to the fact that the width of the street right-of-ways are not the same throughout the City the following is a list of guidelines accepted by the City for the placement of your signs in the non-residential neighborhoods,
  - East Downing Street: signs shall be placed a minimum of 25 feet from the back of the curb or street edge. Signs shall be located behind all sidewalks.
  - South Muskogee Ave. from First Street to Arby's: signs shall be placed a minimum of 20 feet from the back of the curb or street edge. Signs shall be located behind all sidewalks.
  - South Muskogee Ave. from Arby's to the Bertha Parker Bypass: signs shall be placed a minimum of 45 feet from the back of the curb or street edge.
  - > South Muskogee Ave. from Rayne Street to highway 82: signs shall be placed a minimum of 55 feet from the back of the curb or street edge.
  - > Bertha Parker Bypass: signs shall be placed behind the bypass fence and shall not be attached to the fence.
- 3. Sight Triangle: signs shall not be placed in a sight triangle. The sight triangle is the area within a triangle formed by measuring a distance of thirty feet (30') along the front and side lot lines of a corner lot formed by two (2) intersecting streets, from their point of intersection, and connecting the points so established to form a triangle on the area of the lot adjacent to the street intersection.
- 4. Temporary signs advertising political candidates or parties involved in public elections are exempt, provided that such signs may not be erected before the applicable filing period and shall be removed within ten (10) days following such election; or signs advertising support or opposition to any other public election issue, provided that such signs shall not be erected more than thirty (30) days prior to an election on the issue and shall be removed within ten (10) days following such election. Such signs shall not be placed in public rights of way.

Signs found not to be in compliance will be removed by the City. All signs that are removed by the City will be kept at the City Solid Waste Services located at 1851 Douglas until ten days after the election, at which time; the City will dispose of all signs that were removed by the City.

## December 2019 Directors report

This month has been working on the scanning of the documents of voter's forms that are not in their scanned documents file. I have completed 2 file cabinets so far.

This takes a lot of time, also we are identifying <u>most</u> the documents of the deceased voters and sending to the Tribal registration for verification to be able to delete from our files. I hope that after we have gone through the files we can send those lists of the voters from 1894 to 1920 and ask them to find them in their records company that they use to get the rest out of our files.

I am have been working on the election note books and forms. The forms will be numbered and placed in the notebook in order for the future elections. If the Election Act is completed and there are changes the forms are ready for the changes that reflect the Election Act.

Worked with Maxim on the labels for the folders and VR forms so that they come out by Roll Number to allow only one sorting of the voter registration forms.
