

REGULAR MEETING February 11, 2020 CHEROKEE NATION ELECTION COMMISSION

Call to order/Roll call of Commissioners:

The meeting of the Cherokee Nation Election Commission was called to order by Chairperson Shawna Calico at 4:03 p.m.

Commissioner Carolyn Allen called roll and a quorum was established with the following commissioners present:

Office staff present were Marcus Fears and Connie Parnell.

Election Commission Attorney Harvey Chaffin was present.

Approval of Minutes:

Chairperson Shawna Calico asked for approval and/or discussion of the minutes of the January 14, 2020 regular meeting. Rick Doherty made a motion which was seconded by Randy Campbell to approve the minutes of the January 14, 2020. The motion was approved by all commissioners.

Administrator's Report:

Marcus Fears gave the Administrator's Report which included updates on voter registration statistics, voter outreaches attended, scheduled community meetings and a report from the Rules Committee. Our office is making contacts to schedule voter outreaches and education in schools, clinics and other events. An update was given on the progress of scanning documents. Connie Parnell gave the Election Director's report which included progress on scanning documents, identifying deceased voters and working on documents for future elections. Discussion was held. No action was taken on this item.

-The scanning of documents is still going well. I counted today there are 30 cabinets of records and we have completed or are working on 14...so nearly halfway through all the records.


-Interest in next year's election is starting to pick up. We have fulfilled information requests for Voter Lists, Voter History etc. for half a dozen citizens just in the past month.
